	Separate Stock – Vaccination Lot Selection	All	Separate Stock feature flag must be enabled to test this change. Ordering Intention is displayed on the Vaccination Lot Selection module.
	IN Immunization Signature Form	IN	Made changes to display Guardian 2 details on IN Immunization Signature Form.

	Remote Registry	All	Fixed the below issues for Remote Registry: * Fixed the issue displaying an incorrect error message as "Message Rejected" for the messages that are accepted. * Corrected the text description for response messages that were previously not displaying to appropriately display.
HDSD-1090	End Session	All	A Stack Trace error is no longer displayed when selecting End Session on the Administration screen.
<u>HDSD-880</u>	Fund Type Split	All	Previously, multiples of the same VFC PINS displayed in Fund Type Split Report for different Facilities. Now, only one Facility VFC PIN is displayed.
HDSD-1221	Vaccination	All	When the property 'Save Vaccination Default Date for Session' is enabled, the default date on the Vaccination View/Add Screen was not being saved for the duration of the session. Now the date will be saved. This was a problem for users who were accustomed to having the default date save for the entire session and could result in erroneous dates added when the dates were not verified at the time of data entry.
<u>HDSD-600</u>	Receive Orders	All	Previously, orders with inactive NDC numbers couldn't be removed/archived from the Orders screen. Now, orders with inactive NDC numbers can be removed/archived from the Orders screen.
HDSD-1052	Serology	WY	The Serology Module is activated for WY.
HDSD-1330	Vaccination	All	All vaccination date boxes are now visible on Vaccination > View/Add page without having to scroll.

## **Database Release Notes**

The following briefly addresses changes in the database for users with read-only access:

- Code changes to add new match set 125(PASSPORT+DOB) in H33\_WEIGH, corresponding changes to evaluate and pass PASSPORT in H33\_REPLACE\_CHECK and H33\_FIND\_DUPLICATESUNO-1890 Addition of two new name fields and a flag to db tables to indicate data is from authoritative source in the database.
- Inclusion of the new name fields and authoritative flag (OFFICIAL\_PATIENT\_DATA) and logic in the patient stored procedures.
- New property and setting to prevent overwriting the name data, dob and QID from MOI by another organization.
- Add official patient data and patient master overwrite block logic to stored procedures.
- Added state jurisdictional status logic.
- Added county\_jurisdictional\_status.
- Fixed issue with Dedup Patients not processing records for when submitting passport or visa.
- Corrected code to populate COUNTY\_CODE correctly.
- Implement mapping table for observation codes.
- Migrate existing contraindications to map to vaccine family rather than vaccine code.
