	MyIR Verifier Permission Added	All	 MyIR functionality has been added to the application. 'MyIR Verifier' permission has been added to the permissions list on the User Maintenance page. 'Verify MyIR' button will display on the Patient Demographics page when the user has the 'MyIR Verifier' permission.
	LMS Keycloak Role added for SSO Log-In	All	Upon request, the LMS Keycloak role can be assigned to all existing users with the 'Access IWeb' Keycloak role. No Login and Inactive users will not be assigned the LMS Keycloak role.
	Coverage Rate Report	All	The Coverage Rate Report can now be run by Geographic and Provider Level PAIS. The Coverage Rate Report can be run by State Level and County Level Status. Each of the above options has the values: Active Only Inactive Only Unknown All 'County' drop-down was added next to County Level Status option and only displays if County Level Status is set to 'Active Only'.
	Coverage Rate Report	All	Previously, the Coverage Rate Report included deceased patients when run by "All" (Organizational Status, State Status, and Jurisdictional Status). Now, deceased patients are not included when running the Coverage Rate Report under this scenario.
	Reminder Recall	All	Reminder Recall can now be run by State Level Status and County Level Status. • Each option has the values: • All active • All active with inactive Organizational Level Status • All Unknown

The following table lists the detailed information about each of the bugs fixed in this version.

	First Responder	ОН	Previously, First Responder displayed an error when selected from the application's drop-down list. Now, the First Responder page is displayed appropriately.
HDSD-1856	Facility Merge	LA	Previously, Facility Merge displayed an error that was related to a foreign key constraint on a table used by the High Risk HepB module. Now, the foreign key constraint has been removed from the table; which will eliminate the error.
HDSD-1856	Facility Merge	ОН	Previously, a Facility Merge would fail when the eliminating Organization/Facility had an address with duplicate Zip Codes and Vaccine administered. Now, Facility Merge will not fail in the listed scenario.
HDSD-1083	Deduplication	All	Previously, patients would be stuck in Patient Possible Mix table after manual deduplication. Now, patients will not be stuck.
HDSD-982	Provider Allocations	All	Previously, the allocated amount was not displaying correctly when ordering. Now, the allocated amount displays correctly during the whole ordering process with Allocations.
HDSD-983	State Allocations	All	Previously, the Provider Allocation was not displaying for all vaccines in the allocation order set; even when allocation existed for them. Now, all vaccines in the allocation order set will display correctly.
