	Cold Storage	All	 The following are new features/functionality for Cold Storage: The new requirements for Cold Storage manufacturer, effective date, and model number can be toggled on and off in the Required Fields section, this will affect the Cold Storage and Provider Agreement pages. The default setting for all Cold Storage fields on the Required Fields section is <i>on/enabled</i>.
HDSD-1440	DTT	All	NDC and Funding Source fields were added to the Lot Import field options in the DTT.
	Lot Number	All	Added "Unit of Use" text to Lot Number fields in IWeb for the purpose of selecting lots for administration.
			 Consent Status section is now displayed in Mass Immunization on the patient demographics page. The Add Anonymous option is available to users for adding vaccines to patients who are no consent or undetermined. Vaccination Add and Special Consideration Add sections now are visible based on the value of Consented and Bypass permission. Mass Immunizations module will now restrict the patient record report to display for only those patients marked as consent = "Yes" Patients with consent value = "No" are excluded from the patient detail report. Note: Currently MT is the only state that has the Opt-In module enabled.

	Serology	All	Added new functionality for duplicate serology tests (same organization + same test + same draw date) and prevented these from being added from the UI. This helps to simplify the system, especially when modifying an existing serology test versus adding a second duplicate test within the UI. This also impacts duplicate tests and the effect they can have on issuing a contraindication.
HDSD-2489	CIS Form	MS	 Age changes were made for two certificates. 1. The CIS certificate will check the box "Requirements met for attendance at the childcare center (until entry to K4)" for patients under 5 years before September 1st 2. And will check the box for "Requirements met for attendance from K4 to 6th grade" for patients who are 5 years old as of September 1st.
	CIS Form	WA	The date of birth was changed to MM/DD/YYYY and the text "any combination of IPV/OPV" in the IPV/OPV row was removed. The font size was reduced for the <i>Series Name</i> , <i>Expiration Date</i> and <i>Validated by IIS On</i> data fields.

	Address Handling	All	Fixed an issue affecting the addition of patients with a phone number but not an address, which previously inserted a blank row in an address table in the database. The blank row is no longer inserted.

			Also, added data fix to remove blank addresses from address reserve, or addresses with a blank address_street1, city, state, and zip.
<u>HDSD-2573</u>	CPT/CVX Codes	All	CPT & CVX Codes were updated to match the code sets as published by the CDC. This will resolve existing problems with valid codes being rejected by PHC Hub.
HDSD-2412	DTT Import/Lot Inventory	All	There was previously an issue of a vaccine code was not populating when a CVX code was uploaded via DTT. The application now allows for DTT import of inventory that contains the Lot Inventory CVX Code.
HDSD-1239	Manage Population Tool	All	Previously, the Manage Population Tool displayed an incorrect last vaccination date for some patients. Now the displayed date is the last vaccination date.
HDSD-1288	Patient Merge	All	Previously when separating a bad patient merge, lot facility information was missing from the patient record and the vaccine was added back to the lot number inventory. Now, the vaccines are returned to each patient.
HDSD-1858	Pandemic Agreement	All	Corrected an issue affecting Pandemic Agreement documents that were not displaying when selected. This issue has now been resolved and the display is functioning properly.
HDSD-2532	Pandemic Order Set	All	Correct an issue regarding the Fulfillment Type not displaying the Pandemic option when editing an order set. Now when editing an order set marked as Pandemic Fulfillment Type, the Pandemic designation remains.
HDSD-2173 HDSD-2393	Provider Agreement	All	Fixed an issue affecting physicians displaying errors for provider agreements that are already in the registry. Now, you can update Physician/Facility Associations properly.
			Fixed an issue concerning the errors for medical license number fields not containing the proper amount of numbers. You are now able to close the error message and the user is able to enter information afterwards as expected.
HDSD-2280	Waiting Room	All	When users previously clicked the "Waiting Room" link in the Patients Menu, they received an application error. Now, the Waiting Room module is working and displaying data properly.
HDSD-2481 HDSD-2570	CIS Form	MS	Previously, the 121 form for MS was validating a temporary compliant result instead of complete for 7th- 12th grade. The 121 Form for MS is now correctly validating the immunization certificate for grades 7-12.

			Previously, the third Hep B dose was not valid and was forecasting another dose but was showing complete on the MS 121 form. Now, the third invalid Hep B dose is marked correctly and is predicting another dose. The MS 121 form is not displayed because immunization requirements are unmet.
<u>HDSD-1179</u>	CIS Form	MT	Previously, the Complete IZ Form was considering Tdap and DTAP/DT/TD dose number count in determining what to display, but they were considered separate vaccine groupings in imMTrax. Now, DTAP / DT / TD and Tdap vaccines count as separate vaccines based on the number of dates shown.
			Previously, adults over 21 with no DTAP/DTP history who had a single Tdap in their record defaulted to 6. Now, adults 21 years of age and older with no DTAP / DTP history who have only one Tdap on their record have a serial number of 1, allowing further forecasting of Td doses.
			Logos on the form were cutting off when users have print settings set to "Actual Size" and this has now been resolved.
HDSD-2621	Mass Immunizations	MT	When navigating to Mass Imms Reports an error message occurred. Now, mass immunization reports are added for MT and can be accessed properly.
HDSD-1002	Patient Reserve Table	ОН	Created data fix for OH regarding records that had an inactive_code of X in the patient reserve table and an owner irms_sys_id of null in the patient master table.
HDSD-2406 HDSD-2455 HDSD-2399	CIS Form	TN	The ICVT was incorrectly requiring a dose of polio for childcare/preschool as soon as children reached their 4th birthday. Now, ICVT only requires 3 doses of Polio for the Childcare/Preschool category.
			Previously, the ICVT was passing records and producing validated certificates for records that should be failing, and therefore producing a temporary certificate. Now, the ICVT does not pass the records if the patient does not have the required number of vaccine doses.
			The TN ICVT was incorrectly evaluating Tdap when a dose was administered as part of a catch-up schedule. This caused some certificates of immunization to not be validated when they were valid. Also corrected the Tdap forcasting for TN ICVT when Tdap should satisfy the Dtap dose.

HDSD-2462 HDSD-2488	CIS Form	WA	When a CIS Certificate has the CONDITIONAL status, the expiration date was not showing on the first page. Now, the CIS certificate with CONDITIONAL status shows the expiration date (recommended date + 30 days) on page one.
			Previously, vaccines were being displayed incorrectly on page 2 of the CIS. Now, the CIS page 2 red section shows the Invalid vaccines and the Required vaccines to complete the series with the recommended date.
			Previously, when laboratory evidence of immunity was entered separately for Measles, Mumps and Rubella (not as MMR or MMRV) the CIS correctly said Complete, but the word Immune did not print in the Positive Titer column in the MMR row. Now, the word Immune is printed in the Positive Titer column of the MMR row if there is laboratory evidence of immunity entered into Special Considerations for Measles, Mumps, and Rubella.
			Previously, CIS said COMPLETE and Tdap was listed on the second page of the CIS Form under Required Vaccines for School Entry. Now, when a patient is administered a Tdap at 7 years and the <i>Check for Tdap at 7 years or Older</i> is checked, the Tdap is valid and the CIS Certificate status is COMPLETE. Tdap is not listed under Required Vaccines for School Entry.
HDSD-2465 HDSD-2472	SNM	WA	When run with validation series Grade 8-12 (which allows a Tdap administered at age 7 or older to count as the required Tdap dose) a student with a Tdap administered age 7-9 years will be complete on the roster and will not display on the Action Report.
			Previously, the School Nurse Roster was incorrectly calculating the status field, leading to confusion on the students' status. Now, the recommended date is considered for the calculation of the status as intended.
