Employer option is displayed on the Facility Maintenance page. Nursing Home was added to the Facility Type drop down list on Facility Maintenance page. Employer field has been added to Patient Demographics page. The occupation field has been added to the Patient Demographics page. When the iCAT property is selected and the user has the iCAT permission, the new Assessment Patient Attributes section is displayed on the Patient Demographics page. The Title of EMT and DDS are available in the Title drop-down list when configuring and updating a physician/vaccinator.

Serology functionality was added for outbound VXUs. HL7 messages can be sent with CVX 998 to indicate no vaccination was administered. Added support for Ethnicity to PID-22 in outbound VXU and Query response. Supported codes are Hispanic or Latino, code 2135-2, and not Hispanic or Latino, code 2186-5.

	Patient Search/Add	All	Patient search/add is now more consistent. When a user has the <i>Suppress Demographics Address Check</i> permission, a patient can be added with an address or with just a phone number. When a patient is added with just a phone number the message "or phone number" has been removed from the warning message.
	Facility Maintenance Page	All	Previously when selecting the Employer check box on the <i>Facility Maintenance</i> page the Facility Type field was required. Now, after selecting the Employer check box, Facility Type is not displayed as a required field.
<u>HDSD-2720</u>	Historical Vaccinations	All	When a provider was previously adding historical vaccine information, fields that were not required were being marked as required. This limited the provider's ability to enter historical information. Now the user has the ability to save changes or make edits to a historical vaccination without entering provider, lot number, and manufacturer information.
<u>HDSD-962</u>	Issue Resolution	PHC Hub/All	Previously, when submitting a message with an invalid Guardian Address City an issue resolution (of either error, warning, or ignore was not produced). This problem was resolved, and an issue resolution is now produced for invalid Guardian Address City. This was impacting data quality for Onboarding.
HDSD-2728 HDSD-2780	Reports	All	Previously, when running the Patient Detail Report by Service and selecting a Funding Source, there was an application error. Now, the Patient Detail Report works correctly running by Service.

HDSD-1752	Physician Add/Update	WA	An issue was corrected as previously a format check was incorrectly applied when adding a provider Medical License Number. This affected adding new physicians. Now the Medical License Number is formatted correctly and there is no error when adding new physicians.
