	Issue Resolution/PHC Hub	All	Added an issue resolution for PID-22 Patient Ethnicity.
HDS-2797	Mass Immunizations	All	<p>In the Mass Immunization Module on <i>the Personal Settings</i> page, the user will be able to Enable/Disable "Automatic City / State / Zip Code population"</p> <p>Extended the field length of first and last names in the Mass Immunization module to match core IWeb. The first name limit is 48 characters, and the last name limit is 100 characters.</p>
	Ultra Cold Storage	All	Added Ultra Cold storage units to the Cold Chain Tolerance Exception report.
	Vaccination Event ID	All	Added a unique ID for vaccination events to the vaccination tables. This ID is not displayed in the UI but is used as an identifier for the Covid-19 reporting. This permanent field replaces previous functionality that included generating the vaccine event ID at the time it was needed.
	VTrckS	All	The Additional Status in Organization or Facility Details page will populate "2" in the Master VTrckS order file when "COVID" is set.
	Security	All	<p>Updated the code to remove security vulnerability in the following locations:</p> <ul style="list-style-type: none"> • Query Handler • Hep B Screening • Pocket of Need
	PHC Hub	All	PHC Hub libraries were updated with the latest CDC code sets to include the latest manufacturers, CVX and CPT codes for COVID-19.
	iCAT	All	<p>The following changes were made for iCAT:</p> <ul style="list-style-type: none"> • Ability to remove all people from a roster is ready. • The fields: Employer, Campaign, Population Group and Occupation have been added to DTT. • A user with iCAT permission can manage the list of employees and population groups.

			<ul style="list-style-type: none"> Employer group and Population group were added to the reminder recall.
	DTT	All	<p>The ability to import and export serological information using DTT is ready.</p> <p>When using DTT on the mapping screen for funding source, the description is now displayed.</p>
HDSD-2107	Reports/Anonymous Patient	All	<p>The index was added to IS_ANONYMOUS in both tables H33_PATIENT_MASTER and H33_PATIENT_RESERVE.</p> <p>Anonymous Patient was excluded for the reports: Registry Statistics Patient Totals, Coverage Rate, Patient Totals, Contraindication Report and Aggregate Contraindication Report.</p>

HDSD-1481 HDSD-2829	Birth File Number/Patient Merge	All	<p>Added additional messaging for the <i>Prevent Merge of Different Birth File Numbers</i> property to ensure that users who are doing manual merges do not inadvertently merge patients with the same birth file number.</p> <p>When the property is enabled and the patient data is exactly the same but contains a different birth file number, the records go to manual review. It is following the property directive of not merging. It allows a person to review the records to make a decision if this patient should be merged or not. To help prevent users from merging these two records on accident, if the property is enabled a warning has been added at the time the user clicks the <i>Merge</i> button that says: “These patient records have different birth file numbers. Are you sure you want to merge?”</p> <ul style="list-style-type: none"> If the user selects Yes, the process continues as is and the records are merged If the user selects No, the user is returned to the same screen and they will then need to click on the <i>New Patient</i> button.

HDS-2783	Facility Edit	All	Improved the slowness that presented within <i>Facility Edit</i> . The <i>Facility Edit</i> screen can be configured to have a county dropdown.
	IZ Gateway/PHC Hub	All	Corrected an issue involving the ethnicity. Previously when Unknown or Other was added within the UI, the outbound VXU contained a number in PID-22. Now, PID-22 of the outbound VXU only contains valid codes or blank.
HDS-2684 HDS-2666 HDS-2664 HDS-2669	Mass Immunizations	All	<p>Lot Defaults from <i>Facility Settings</i> in IWeb were not transferring to Mass Imms when the property was checked. An error was fixed and now Lot Defaults from <i>Facility Settings</i> in IWeb are transferred and display in Mass Imms properly.</p> <p>In Mass Imms, when a user entered a Default Date under Vaccination Defaults on the <i>Facility Settings</i> page the date was not saved and displayed properly. The issue was fixed, and the Default Date now displays properly in Mass Imms.</p> <p>Previously, Lot Defaults from <i>Personal Settings</i> in Mass Imms were not properly saving. An error was fixed, in the <i>Personal Settings</i> section of Mass Imms and Lot Defaults are saved as intended.</p> <p>The Patient Detail Report in Mass Immunizations can now be limited by Tier.</p>
HDS-2090 HDS-2203 HDS-1537	Deduplication		Resolved the problem involving records being stuck in the patient pre-reserve table. Previously exact match patient records remained in patient pre-reserve if the existing reserve record contained more than one phone number marked as primary. This caused deduplication for the patient record to fail with too many rows returned for phone number. Deduplication was modified to return only one primary phone number for the patient during evaluation.
HDS-2714	Reports	All	Previously the <i>Vaccine Administered Report</i> returned an application error when the user selected multiple vaccines. The error was fixed, and the Vaccine Administered Report runs as expected.
HDS-2533 HDS-2659 HDS-2733	CIS Form	MS	<p>Previously the CIS Form was being validated incorrectly. Now, the CIS Form correctly validates the patient's certificate and the Expiration date.</p> <p>The temporary compliance form was not populating with an expiration date. Now, the temporary compliance form shows the expiration date with a valid date as expected. Both issues were impacting user's ability to generate a valid CIS Form.</p>
