The following are new features, functionalities, or enhancements in this version of IWeb.

| Кеу | Summary | Affects Client | Description |

| | Coverage Rate Report | All | In the <i>Define Coverage Rate</i> Report series, the vaccine group for COVID-19 is listed as an option under the column <i>for Select Vaccines</i> . The COVID-19 <i>Series</i> <i>Coverage Rate</i> Report works for all three types of COVID-19 vaccines. |
| | iCAT | AII | The following features are additions to iCAT: Ability to add multiple employers to patient was enabled. Ability to import and export patients with Multi Employers through the DTT import file. Patient Demographics show all employers of all Organizations. Ability to manage the population through the Roster and perform searches using multiple employers. |
| | HL7 Import | All | Following the AIRA guidelines, PHC Hub now process Campaign and Population group in HL7 messages. You can define issue resolution in PHC Hub for these fields. This information is viewable on the patient demographics screen. |
| | Guardian Signature | All | For those states who have guardian signature enabled, the ability to capture a consent signature at the time the vaccine is recorded is available. In order to enable this feature, you would click <i>Enable Consent Signature Capture</i> under the Vaccination header under properties. After this is selected, the administrator has the option to customize the message to display. Once enabled, a guardian signature can be captured during the add administered vaccine workflow. This signature is then viewable when looking at the vaccination detail for each vaccine. |
| | Manage Population | All | When a user deletes a vaccine, the <i>Last Vaccination</i> <i>Date</i> column on the <i>Manage Population</i> page will update. |
| HDSD-512 | Personal Exemption | MT, DC | The Personal Exemption option has been removed from Special Considerations for Montana and DC. |
| | Security | All | Fixed a problem with SQL Injection on CASA Export. Fixed a problem with SQL Injection on add Lot Numbers |

| | CIS Form | DC | For Washington DC, the Universal Health Certificate for a patient is ready and can be printed. |
| HDSD-2998 | Main Menu Configuration | PR | The new main menu image is available for configuration in Puerto Rico. The new image name is Logo PREIS.png and can be configured under Administration > Properties > Images > Menus Top Image |

The following table lists the detailed information about each of the bugs fixed in this version.

| HDSD-2954 | Add Anonymous | | Previously when adding an Anonymous Vaccine with a VFC Status of Ineligible and a VFC lot, the vaccine information was cleared. Now, when the user adds an Anonymous vaccine that has the status VFC Ineligible, the name of the vaccine remains on the <i>Vaccine Detail Add</i> page and the lot number remains available on the pop-up page for the selected lot number. The vaccine can be saved. This allows for vaccine level accountability in the instance of borrowing inventory. |
| <u>HDSD-2785</u> | Anatomical Injection Site | All | Attempting to update any of the Anatomical Injection Site defaults, by clicking the update button was display a "The age range specified overlaps with another injection site default of the same vaccine type" error. This was been fixed and a user can now update the defaults. |
| | ICAT | All | Previously, the <i>Occupation</i> field was not updating correctly when trying to remove an occupation. Now, the <i>Occupation</i> field can be left blank or can be populated with the list of occupations, regardless of the organization that was entered. |
| | DTT | All | The DTT Exports that contain passport or visa can now be generated. Previously an error would be displayed in the text file. |
| <u>HDSD-1837</u> | Facility Maintenance Page | All | Previously, some email addresses were not saving properly on the <i>Facility Maintenance</i> page. Now, IWeb allows the user to update the email address <i>on Facility</i> <i>Maintenance Details</i> page and saves as expected. |
| | Facility Settings/Lot Defaults | All | Fixed a usability issue when setting lot defaults on the <i>Facility Settings</i> page. Previously, after saving a new lot, the lot default list would display as blank and the user had to refresh or return to the screen to see the saved information. The information now displays immediately after save. |

| <u>HDSD-2742</u> | Funding Source | All | When using Personal Defaults, the <i>Funding Source</i> field was populating incorrectly. Now the <i>Funding Source</i> field is populated with the Default Value. |
| HDSD-3087 | Inventory Transaction Report | All | Previously the Inventory Transaction Report was displaying the incorrect receiving Organization/Facility for transaction entries. The issue was fixed, and the Inventory Transaction Report displays the correct Organization/Facility for transaction entries. |
| <u>HDSD-730</u> | Manage Population | All | Previously, the <i>Manage Population</i> Sort functionality was not working as expected. Now, <i>Manage Population</i> lets the user see the records by blocks of 250 entries and allows the user to page between them using the arrows. To view the next block of 250 entries, use the Next button. The application allows you to sort each block by patient ID, patient name, and patient's date of birth. |
| HDSD-3033 | Deduplication | All | Fixed issue where if the phone number pre reserve sequence was greater than the patient pre reserve sequence, deduplication took a unique constraint error, and records stayed in pre reserve table. |
| HDSD-3089 | PHC Hub | All | Previously, PHC Hub displayed an error for QBPs when queried for deleted vaccines and the 'Send Vaccination Delete' setting was enabled. The issue has been fixed and QBPs work as expected. |
| HDSD-1119 HDSD-3166 | Reminder Recall | All | Changed the Vaccines Due figure on the second page of Reminder Recall to: Only count vaccines from the selected series, instead of counting all due vaccines To take the Due Date Timeframe into account Previously, some vaccines like COVID-19 were not counting correctly. The issue was corrected, and Reminder Recall runs as expected. Fixed issue where Reminder Recall took an Index out of bounds error when a report was run for a Custom COVID- 19 series and with either one dose away or one visit away. Previously, there was an issue parsing Meningococcal B vaccines in the Reminder Recall CSV file. Now the MENINGOCOCCAL B, RECOMBINANT and MENINGOCOCCAL B, OMV does not split into two columns after the comma. |
| | School Nurse Module | All | There was an empty space on the <i>Action Report</i> , when running the K-6 Series and a patient was over 7 years old and missing DTAP family vaccines. Now, when a patient doesn't have a School Exemption for Dtap/DT/Td and the Forecast requires a Dtap or Tdap vaccine, the <i>Action</i> <i>Report</i> will show Dtap or Tdap vaccine as required. |

| | | | Previously, the At Risk Report did not update when the patient has a disease exemption. Now, when a patient has a disease exemption, the At Risk Report takes the disease into account and marks the related vaccine as Compliant. If the disease is related to a compound vaccine such as MMR, only if the patient has exemptions for all 3 diseases that make up the vaccine (Mumps, Measles and Rubella) then the At Risk Report must take the disease into account and mark the related vaccine as Compliant. |
| <u>HDSD-2659</u> | CIS Form | MS | Previously the MS CIS Form was not validating the patient's certificate correctly. The issue was fixed, and the CIS form correctly validates the patient's certificate and the expiration date. |
| HDSD-2472 | School Nurse Module | WA | Previously a vaccine dose required by the selected evaluation series in the forecast with a recommended date 30 or more days less than today was incorrectly causing the roster to be marked as Conditional. Now, a vaccine dose required by the selected evaluation series in the forecast with a recommended date 30 or more days less than today will cause the roster status to say Not Complete. |
| <u>HDSD-2685</u> | CIS Form | WA | Previously the WA CIS Form was incorrectly marking a Grade 7 student in need of Tdap as Complete. Now the WA CIS is working correctly for a 7th grade student in need of Tdap, when they have received 3 previous doses of Tdap before age 10 to complete a DTaP recovery program. The CIS status is Incomplete and the Tdap vaccine appears in the Required Vaccines for School or Childcare Entry. |
| HDSD-2694 | Manufacturer | Qatar | Included the global scripts to add in manufacturers that are outside of the US. These scripts had been previously run manually on the global build. |
| | Inwani Address | Qatar | Previously the patient's Inwani Address was not saving properly when multi-address was enabled. Now, the Inwani's patient address is being saved. Now we can have two main addresses, one for Inwani and one for the traditional address. |
