	Deduplication	All	Changes made to the Approximate Date of Birth logic in the Deduplication code so that correct match decision is leveraged.
	Daily COVID Extract	All	Added index on address_city to the facility master and patient master table to increase performance of the daily covid extract.
	MyIR	All	Added application state code to MyIR Verifier in IWeb in order to determine what state the account is linked to.
	NDC	All	The NDC format has been updated to accept 11 digits without hyphens and 10 digits with hyphens.
	Pandemic Registration	All	<p>E-signature has been added to the Pandemic Registration process. When the approver is ready for the Organization/Facility to sign the Pandemic document, they will select the "Waiting Signature" status on the <i>Approval pages</i>. Once the form is in this status the Organization/Facility can go in and e-sign the document.</p> <p>After the Organization/Facility has submitted the signature the form status will automatically update to Approved.</p> <p>Currently, e-signature is enabled for all customers when Pandemic Registration is enabled.</p>

<a href="#">HDSD-2613</a>	PHC Hub	All	<p>Fixed issue where a QBP returned a repetition in RXA-5. Now a CVX code is always returned. If present, an NDC is returned. If an NDC is not present, a CPT code is returned. A repetition is not returned.</p> <p>PHC Hub libraries were updated with the latest CDC code sets to include the latest CVX and CPT codes for COVID-19. CVX codes 211 and 214 were added.</p>

If the property is enabled in IWeb the Mass Immunization Module will also prevent display of Social Security Numbers.

## Fixed Bug List

The following table lists the detailed information about each of the bugs fixed in this version.

Key	Summary	Affects Client	Description & Impact
<a href="#">HDS-3939</a> <a href="#">HDS-3933</a> <a href="#">HDS-3901</a>	CIS Form	All	Previously an application error was received when accessing PDF generated patient record reports. This impacts the ability to provide patients with a CIS Form. Now, CIS Forms load as expected.
<a href="#">HDS-3668</a>	DTT	All	Added address city length validation which will prevent invalid city names over 30 characters from being imported with a DTT or HEDIS import file. Allowing this data to be accepted into the system was causing the import to fail.
<a href="#">HDS-1469</a>	Patient Demographics	All	Previously, when Multi-rows for Family & Contact is enabled and a user was editing the patient demographic page where Guardian information was present, an error message appeared when clicking <i>Save</i> . Now, when guardian information already exists and the user clicks <i>Save</i> , the application does not send an error message.
<a href="#">HDS-3699</a>	Master Patient Data Access	All	Fixed issue where the <i>Patient Demographic Master View</i> page did not display available visa and passport numbers when a user had Master Patient Data Access.
<a href="#">HDS-3025</a>	SIIS Facility ID	All	The vaccination detail page was incorrectly displaying the SIIS Facility ID of the user logged in. Now, when a user selects a vaccine the details reflect the correct facility information.
<a href="#">HDS-3916</a>	Patient Changes Report	All	When a user ran the <i>Patient Changes Report</i> they received an application error. This impacted the ability to audit patient records. The issue was fixed, and the user can run the report as expected.
<a href="#">HDS-3907</a>	Returns	All	Previously when submitting a return with a Return Depot the user received the error <i>'Form cannot be submitted multiple times'</i> . The issue was fixed, and the return can be processed as expected.
<a href="#">HDS-2291</a> <a href="#">HDS-2321</a>	Address Records	All	This release includes a data correction fix for Address Reserve Records that had multiple primary addresses for the same asiis pat id + irms sys id. This bad data was a result of a previous application fix that did not include a data correction. The correction makes the Address Reserve Record with the greatest address id the primary and the other addresses secondary.  This will resolve the issues that users are seeing with the display of address being different on the patient demographics screen as compared to the patient record reports and certificates.
	Reports	All	Previously, when a funding source that could be counted in reports was set to "select" in <i>Administration &gt; Define and Map Eligibility Categories</i> , selecting All Eligible on the <i>Patient Detail Report</i> or <i>Vaccine Totals Report</i> caused an application error. Now, the reports are created with the records it can return and leaves out the records that are set to "select."
