CONSORT-4603	Case Listing Export - When Lab Reports is set to Yes (One Lab Report per Row)	AII	 Fixed issue where Case Listing Export displays the Lab Report details, only for the First Lab Report (When Lab Report - Yes (One Result per Row) export parameter is selected and when there are more than one Lab Reports for a case). Set Up: Have two Lab Reports for a case. Steps to Test: Log in to Sentinel as a System Admin/Super user. Search for the above case.

			 Click Export. On the Case Listing Export window, Select the export parameters as below: Core Data: Yes or No Notes: No Lab Reports: Yes (One Lab Report per Row) Supplemental Form: Blank. Click Export. Open the downloaded Export CSV file. Notice that Lab Report details for both the Lab Reports of the case are displayed.
CONSORT-4601	Switching between Case Reporting tab and Other tabs for a case	All	Fixed the issue where saving a value for Binational Reporting Criteria field (when selecting imported field to Out of country and Imported country to Canada or Mexico) and then changing the Imported drop-down value to something other than 'Out of Country' displays a pop-up window when switching between the tabs of a case.
			 Steps to Test: Log in to Sentinel as a System Admin/Super user. Click Edit corresponding to a case that is not Closed, Superceded, Completed or Cancelled. Select a value from Imported field. Select a value from Bi-national Reporting criteria field. Click on Submit changes. Click on Submit changes. Select a different value from the Imported field. (Other than the value selected in Step 3). Click on Submit changes. Notice that pop-up window is not displayed with the message "You are about to leave this page. Any changes since your last save will be lost. Note: This error was happening when Binational Reporting criteria field was enabled only when Imported field was set to Out of Country and Country was selected as 'Mexico' or 'Canada'. This issue will no longer happen after the changes made in <u>CONSORT-4598</u>.
CONSORT-4600	Arboviral v1.3 MMG Changes	All	 Made change to have the word SENT prepend before the Investigation ID for the Phin variable 'INV168' in Generic v2 and Hepatitis v1. The prepend word SENT- can be changed using the STC config key - hl7.cnms.INV168.local.record.id.prepend. By default, the key is set to true and is not displayed in STC config.

			 Made change to have the maximum number of characters for the field - "Other Symptoms (Specify)" on Arboviral CDC Form set to 199 characters. The change was made because the maximum number of characters allowed for the Phin's Variable '56831-1' corresponding to this field is 199. Made changes to a few HL7 Table ID values of the Phin Variables - INV2001/2002, DEM 126, INV152, INV153, INV154, INV501,INV163 and INV128 and Phin variables with value-set VS_YNU_ARBO_1 and VS_YNUNK_ARBO_1_3.
CONSORT-4599	Case Listing Export - When Lab Reports is set to Yes	All	Fixed issue where a number 2 is prepended before the Lab name under the Sending Laboratory Name column and a number 1 is prepended before the test name under Lab Test Name column. (Ex: 1 <labtestname> and 2<sending laboratory<br="">Name>)</sending></labtestname>
			Set Up:
			Have a case with two lab reports added.
			Steps to Test:
			 Log in to Sentinel as a System Admin/Super user. Search for the above case that has two Lab Reports. Click on Export. Set the export parameters as below and Click on Export button: Core Data: No Notes: No Lab Reports: Yes Suppl Form(s): Blank Open the downloaded CSV file. Notice that Lab Sending Laboratory Name column has only the name of the Lab displayed and a number 2 is not prepended before the Lab name. Notice that Lab Test Name column has only the name of the test displayed and a number 1 is not prepended before the Test name.
CONSORT-4598	Remove Interaction on Bi-national	All	Made changes so that Bi-national Reporting criteria field is always enabled.
	Reporting		Earlier Functionality:
			 On the Case Reporting tab, Bi-national Reporting criteria field is enabled only when "Imported" field is set as "Out of Country" and Imported Country is selected as "Canada" or "Mexico".

Кеу	Summary	Affects Client	Description
			 This was implemented as per Bi-nation reporting criteria data element description provided by CDC in Arboviral v1.3 Implementation sheet. However, there is a discrepancy in Hepatitis sample test case scenarios where Imported is set to "In-state" and a value is set for Binational Reporting criteria field in the same test case. To address that, It was decided over the Sentinel Consortium call on 1/8/18 to make the below changes.
			New Functionality:
			 Bi-national Reporting criteria field is no longer an interpretation based on the value selected for "Imported" or "Imported Country" fields. The field is now always enabled.
			Steps to Test:
			 Log in to Sentinel as a System admin/Super user. Click Edit corresponding to a case that is not Closed, Superceded, Completed or Cancelled. Notice that Imported is set to 'Unknown' by default. Notice that Bi-national Reporting Criteria field is enabled by default.
