IWeb 5.27.0 must be installed in order for the new features added in VOMS 2.24.0 to function. Once the PED/ADULT new feature is enabled, it can't be disabled without causing vaccine information and inventory issues.

	Order Sets	Previously, products for vaccines in Order Set displayed twice when added to the Order Set, having both a PED and ADU intention for the same vaccine. Now, the product will on display what was selected to be added to the Order Set.
