	Prebooking	IWeb 5.34.0 must be installed for VOMS 2.29.0 to function. The restriction on Prebooking that only allowed one order set has been removed.
		A new section has been added to Admin & Settings, called Define Prebooking Categories. The state can now set up categories with up to three order sets assigned to the category for Prebooking. An Organization/Facility can only be assigned to one order set within a category.
		 Category drop-downs have been added to the following locations to allow providers and the state to switch between categories. Prebooking Provider Request form Assign Provider to Prebooking Prebooking Percentage Allocations Approver Prebooking – Update Provider Forms
		The Prebooking Percentage Allocation page will pull all vaccines in all order sets for the selected category. If a vaccine is in multiple order sets, it will only be displayed once and the allocation set will be used for all order sets.
		The Approve Prebooking – Fulfill Prebooking Request page will pull all vaccines in all order sets for the selected category. If the provider is assigned to an order set that doesn't have a given vaccine the Fulfillment Doses box will be greyed out.
		 The following properties have been removed or moved to a new location on the Property page. Provider Submission Date Range – property has been removed. Date Range is set on Define Category page. Restrict Funding Source – property has been removed as it is no longer needed. Enabled Prebooking – is now located on the General tab.

Кеу	Summary	Impact & Description
HDSD-672	Inventory	Previously, inactive Products would display in the Vaccine Selection drop-down when adding inventory to the application. Now, only active Products will display in the Vaccine Selection drop-down when adding inventory.
<u>HDSD-1157</u>	Prebooking	Previously, the application required percentage allocations to be submitted before another one could be added. This wouldn't allow any percentage allocations to be submitted. Now, a percentage allocation does not need to be submitted in order to submit another one.
